The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

As soon as practicable, but not later than July 1, 2002, widescreen digital television (DTV) displays measuring at least 7.8 inches vertically, DTV sets with conventional displays measuring at least 13 inches vertically, and stand-alone DTV tuners, whether or not they are marketed with display screens, and computer equipment that includes DTV receiver or display circuitry, shall be equipped with caption decoder circuitry which appropriately receives, decodes, and displays closed captions from broadcast, cable, videotape, and DVD signals.	<b>Not applicable</b>	
(b) Television tuners, including tuner cards for use in computers, shall be equipped with secondary audio program playback circuitry.	<b>Not applicable</b>

(e) Display or presentation of alternate text presentation or audio descriptions shall be user-selectable unless permanent.	<b>Supports</b>	<p>Control over the display of captions or audio descriptions in a PDF file is dependent on the capabilities of the media player referenced via the embedded media.</p>

This can result in an unexpected read order when documents contain content arranged in multiple columns or regions.</p>
