A publisher of trade and technical books for business executives, engineers, and other professionals, McGraw-Hill Professional began publishing eBooks in August 2000 and now offers 1,850 titles, a number of which are published in Adobe Acrobat eBook Reader format. 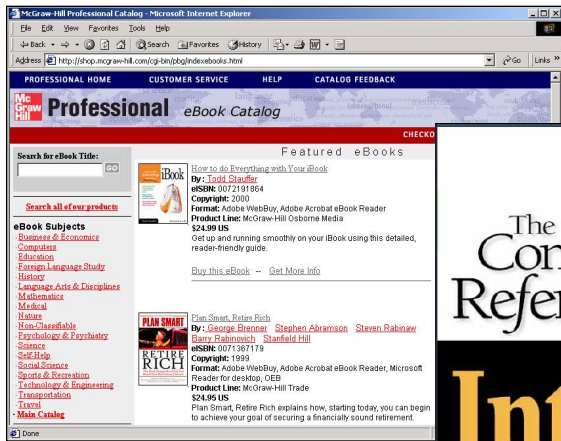

One such company is Lightning Source, Inc., which takes advantage of Adobe Content Server software to package, protect, and distribute eBooks in Adobe Portable Document Format (PDF) and sell them to leading online retailers. Consumers can read eBooks using Adobe Acrobat eBook Reader software, which is available for both the Windows® and Macintosh platforms and can be downloaded at no charge from [www.adobe.com](http://www.adobe.com).

## Adobe Content Server, behind the scenes

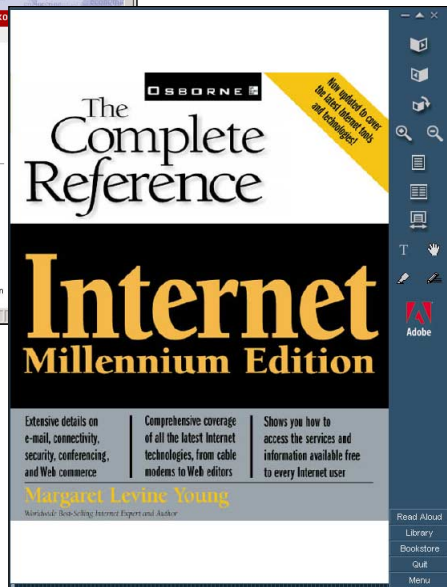
McGraw-Hill Professional starts with the same files prepared for print publication, which are already available as Adobe PDF files. After receiving the Adobe PDF files, Lightning Source takes advantage of Adobe Content Server to make the titles available to retailers and to handle back-end processing of sales, online inventory, and delivery of eBooks to customers. Adobe Content Server also provides digital rights management (DRM) technology. McGraw-Hill Professional was flexible in its selection of usage rules. For example, though purchasers cannot copy eBook content and paste it elsewhere, they can print files for their convenience.

"Adobe Content Server software helps us respond to our customers' needs, whether they deal with the creation of eBooks, management of sales, or delivery of eBooks to customers," says Ed Marino, president and chief executive officer of Lightning Source. "Adobe software enables Lightning Source and other participants in the eBook arena to expand the appeal of eBooks with rich content-presentation formats and a user experience our customers want."

Adds Bolick, "Working with authorized DRM service providers like Lightning Source makes life easier for us and eBook retailers. Lightning Source has the infrastructure, including secure

content management, to protect our publications from alteration or unauthorized distribution. That means we don’t have to invest in an infrastructure, and retailers can conveniently obtain content from multiple publishers from one wholesaler.”

#### The appeal of eBooks

The primary benefit of eBook publishing is that McGraw-Hill Professional can sell the same content in different ways, creating new revenue streams. For example, by using Adobe Content Server to specify the length of read time, the company can “rent” eBooks, checking them in and out for use. And the publisher can slice

and dice its publications in a way that’s impossible with printed books, even selling individual chapters. “With eBooks, we offer our customers more alternatives and can better compete with other publishers. The technology is easy to use and cost effective, in terms of bringing new books to market,” Bolick notes.

The eBook format benefits customers as well. “eBooks satisfy a customer demand in a way that print books do not, giving readers the ability to save time by electronically searching through books,” says Bolick. Readers who use Acrobat eBook Reader can also annotate books with electronic sticky notes, inline notes, and text highlighting without permanently marring the book. They can also navigate easily with search capabilities and bookmarks.

#### True to the author’s intentions

To McGraw-Hill Professional, an important benefit of Adobe PDF for eBooks is that it maintains exact fidelity with the original, including details such as font, color, and graphics. Says Bolick, “Adobe PDF allows us to easily control the appearance of the eBook content so it’s consistent with the author’s intention and our own.”
