Dear David:

WSP has conducted an independent third party review of Adobe's Fiscal Year 2017 greenhouse gas inventory with the intention of providing limited assurance of its accuracy and completeness. The scope of the review includes all Scope 1 and Scope 2 emission sources and select Scope 3 emissions from business travel and employee commuting. The GHG inventory applies to all owned and leased facilities under Adobe's operational control.

WSP provided a "Review Findings" report to Adobe which lists in detail the specific review tasks completed and areas which have been flagged for clarification or improvement. Adobe has addressed all requests for clarification and has completed all necessary corrective actions. The details of the scope of this assurance review can be found in Table 1.
