### LICENSE AGREEMENT FOR PRERELEASE SOFTWARE

This License Agreement for Prerelease Software (the "Agreement") is entered into by Adobe (as defined below) and the Licensee. This Agreement supersedes all prior versions of the Adobe Inc. License Agreement for Prerelease Software entered into for the Prerelease Software, PDF Electronic Seal API Beta. As of the date Licensee clicks "Submit" or similar, Licensee agrees to be bound by the terms below. Adobe and Licensee agree as follows:

IMPORTANT: THIS AGREEMENT IS A LEGAL AGREEMENT BETWEEN LICENSEE AND ADOBE. PLEASE READ IT CAREFULLY BEFORE ACCESSING, DOWNLOADING, INSTALLING AND/OR OTHERWISE USING THE PRERELEASE SOFTWARE AND/OR CONFIDENTIAL INFORMATION. THIS AGREEMENT PROVIDES RESTRICTIONS AND OBLIGATIONS WITH RESPECT TO THE PRERELEASE SOFTWARE AND OTHER CONFIDENTIAL INFORMATION. IN ADDITION, THIS AGREEMENT PROVIDES LICENSEE WITH A LIMITED LICENSE TO USE THE PRERELEASE SOFTWARE AND/OR CONFIDENTIAL INFORMATION AS SET FORTH HEREIN AND CONTAINS WARRANTY AND LIABILITY DISCLAIMERS. BY DOWNLOADING, INSTALLING AND/OR OTHERWISE USING THE PRERELEASE SOFTWARE AND/OR CONFIDENTIAL INFORMATION, LICENSEE IS CONFIRMING ITS ACCEPTANCE OF THE TERMS AND CONDITIONS, ACKNOWLEDGING LICENSEE HAS THE AUTHORITY TO ENTER INTO THIS AGREEMENT AND AGREES TO BE BOUND BY THE TERMS, RESTRICTIONS, AND CONDITIONS SET FORTH IN THIS AGREEMENT.

BY SUBMITTING PERSONAL INFORMATION THROUGH THIS AGREEMENT, LICENSEE UNDERSTANDS AND AGREES THAT THIS INFORMATION MAY BE TRANSFERRED ACROSS NATIONAL BOUNDARIES AND MAY BE STORED AND PROCESSED BY ADOBE AND ITS AGENTS IN ANY OF THE COUNTRIES IN WHICH ADOBE MAINTAINS OFFICES, INCLUDING THE UNITED STATES.

IF LICENSEE DOES NOT AGREE TO BE BOUND BY EACH OF THE TERMS, RESTRICTIONS AND CONDITIONS HEREIN, THEN LICENSEE IS INELIGIBLE TO PARTICIPATE IN ADOBE'S PRERELEASE SOFTWARE PROGRAM.

Adobe is in the business of developing, marketing, distributing and providing software, services and other technology around the world. Licensee desires to evaluate prerelease versions of Adobe software, services and technology. Licensee's evaluation of, and feedback about, Adobe's prerelease software and technology is useful for the further development and refinement of such software and technology. Licensee's participation is useful for Licensee's own personal and professional development related to Licensee's general use of Adobe's software, services, and technologies. Adobe and Licensee agree as follows:

### 1. Definitions.

- 1.1 "Adobe" means Adobe Inc., its affiliates and assigns, a Delaware corporation with its an address of 345 Park Avenue, San Jose, CA 95110-2740 U.S.A. if you reside in North America (inclusive of United States, Canada, Mexico, United States territories and possessions, and United States military bases wherever located); if you reside outside of North America, then your relationship is with Adobe Systems Software Ireland Limited, 4-6, Riverwalk Drive, Citywest Business Campus, Cooldown Commons, Dublin 24, Ireland.
- 1.2 "Confidential Information" means the Prerelease Software, however acquired, any related information supplied to Licensee by Adobe hereunder, and any Evaluation Feedback. "Confidential Information" whether in written, verbal, graphic or electronic form, including without limitation, (a) the Prerelease Software's existence, features and functionality, fonts, user interface details (including screen shots), capabilities, specifications, architectural diagrams, APIs and related information, serial numbers, login identifiers, passwords, Adobe development and shipping schedules, Adobe email lists, bug databases, know how, trade secrets, and source code; (b) any Evaluation Feedback regarding the same; (c) discussions of potential features, product changes and Evaluation Feedback and opinions stemming therefrom, including the existence of any business discussions, negotiations, or agreements in progress between Adobe and Licensee; (d) opinions stemming from the customer advisory boards organized by Adobe; and (e) the terms and conditions of this Agreement.
- 1.3 "Evaluation Feedback" means Licensee's feedback relating to Licensee's access to, use, and evaluation of the Prerelease Software, including without limitation, feedback on features or functionality, usability, specifications, architectural diagrams, APIs and related information, software or hardware compatibility, interoperability, performance, bug reports, test results and documentation requirements, and may also include suggestions or ideas for improvements or enhancements to the Prerelease Software.
- 1.4 "Hosted Services" means an instance of the Prerelease Software made accessible to Licensee by Adobe (or by a third-party host on Adobe's behalf) through the Internet or another network connection for use as governed by this Agreement.
- 1.5 "Licensee" means either (i) an individual who has accepted this Agreement prior to accessing the Prerelease Software or by downloading, installing, accessing, or otherwise using the Prerelease Software or (ii) those employees authorized by their employing organization, entity, or institution when such authorized employee has either (a) accepted this Agreement on behalf of such organization, entity, or institution; or (b) downloaded, installed, accessed, or otherwise used the Prerelease Software.
- 1.6 "Licensee Content" means any content that Licensee uploads including but not limited to, information, data, documents, communications, files, text, images, photographs, graphics, videos, webcasts, tools, resources, software and products that Licensee transmits or otherwise makes available as part of Licensee's testing of the Hosted Services. For the avoidance of doubt, test results provided by Licensee to Adobe regarding the Hosted Service is excluded from this definition and is subject to the Evaluation Feedback provision in the Agreement.
- 1.7 "Prerelease Software" means prerelease versions of the software, services, and technologies, including Hosted Services, and related materials and information as determined by Adobe in its sole discretion including without limitation any development tools, documentation, support materials, sample code, corrections and/or updates supplied by Adobe to Licensee hereunder.
- 1.8 "Testing Period" means the time from Licensee's receipt of the Prerelease Software until the earlier of the first commercial release of the Prerelease Software or Licensee's purchase of a commercial license of the Prerelease Software.

## 2. Privacy.

- 2.1 **Privacy Policy.** The Privacy Policy at <a href="http://www.adobe.com/go/privacy">http://www.adobe.com/go/privacy</a> is incorporated into this Agreement by reference and governs any personal information Licensee provides to Adobe.
- 2.2 **Data Processing.** Where Licensee Content includes personal information and where you are considered a "**Data Controller**" and Adobe is a "**Data Processor**" as defined under the General Data Protection Regulation EU Regulation 2016/679 ("**GDPR**"), the terms of the Adobe Data Processing Agreement ("**DPA**") (available <a href="here">here</a>), including the European Commission approved Standard Contractual Clauses, as applicable, shall apply to the processing of such personal information and are incorporated by reference herein.

### 3. License Terms.

- 3.1 **Evaluation License.** Subject to the terms of this Agreement, Adobe hereby grants Licensee a limited, nonexclusive, non-transferable and royalty-free license to install and use the Prerelease Software during the Testing Period in a test environment on devices located on Licensee's premises solely for the purpose of internal, non-public evaluation of the Prerelease Software and supplying Evaluation Feedback to Adobe. Licensee's access to the Prerelease Software for the limited purpose described herein does not include the right or license to make any public, productive or commercial use of the Prerelease Software, except that, during the Term of the Agreement, Licensee may publish and sell any output created using the Prerelease Software. Prerelease Software may not represent the final product, and any Prerelease Software or the output generated by Prerelease Software may be subject to change upon commercial release.
- 3.2 **Permitted Use.** Licensee grants Adobe a non-exclusive, worldwide, royalty-free license to use, copy, transmit, index, model, and aggregate Licensee Content uploaded or imported via Prerelease Software for the purpose of (1) developing, improving or customizing the Prerelease Software or underlying Adobe services, and (2) publishing, displaying and distributing any de-identified personal information derived from such Licensee Content (such as, but not limited to, web browser, screen resolution, mobile device-type information, structure of a document, number of pages in a document, or image resolution).
- 3.3 **Usage Tracking.** Licensee acknowledges that Adobe may collect information on Licensee's usage of the Prerelease Software, and may use such information to further develop, modify, improve, support, customize or operate the Prerelease Software.
- 3.4 **Hosted Services.** If Adobe has granted Licensee a license and access to test the Prerelease Software as a Hosted Service, as described in this Agreement, Licensee acknowledges that access to and use of the Prerelease Software as a Hosted Service requires the exchange of information over the Internet or another network and the storage of information with the Hosted Service, and Licensee specifically grants Adobe the right to use such information in connection with Licensee's evaluation of the Prerelease Software.
- 3.5 **Proprietary Rights.** Except as expressly set forth in this Agreement, Licensee acquires no other licenses under any intellectual property or other proprietary rights of Adobe. Licensee agrees not to reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Prerelease Software.
- 3.6 **Specific Limitations on Adobe Clean.** The Adobe Clean font, if included with the Prerelease Software, is available only for purposes of operation of the Prerelease Software user interface and not for inclusion within any output files. Adobe Clean is not licensed for any use outside of the Prerelease Software. Licensee agrees that it will not copy, move, activate or use, or allow any font management tool to copy, move, activate or use, Adobe Clean in or with any software application, program, or file other than the Prerelease Software.
- 3.7 **Marketing.** By uploading content created using the Prerelease Software to social media websites, Licensee grants to Adobe a non-exclusive, irrevocable, worldwide, royalty-free right and license to use, reproduce, distribute,

publicly display, and publicly perform Licensee Content in Adobe's marketing materials.

- 3.8 **Limiting Use of Service Output.** Licensee nor Licensee's end users will not use the output of Prerelease Software to create, train, or improve either directly or indirectly a similar or competing product or service.
- 3.9 **Third Party Providers.** If Licensee uses certain features of the Prerelease Software in conjunction with third party data, products, services, and platforms (e.g. social media platforms, media partners, wireless carriers, or device operating systems), then Licensee is responsible for complying with the terms and conditions required by such third party providers, and all such use is at Licensee's own risk.

# 4. Evaluation Feedback.

Licensee agrees to provide reasonable Evaluation Feedback to Adobe during the Testing Period. Licensee grants to Adobe a non-exclusive, irrevocable, worldwide, royalty-free right and license to use, reproduce, distribute, make derivative works based upon, publicly display, publicly perform, make, use, sell and export the Evaluation Feedback, including without limitation the right to sublicense such rights through multiple tiers of sublicensees. Licensee agrees that Licensee has all rights necessary to provide the Evaluation Feedback to Adobe and Licensee acknowledges that Adobe is in no way obligated to incorporate, use or otherwise acknowledge any Evaluation Feedback that Licensee has provided.

### 5. Use of Hosted Services.

Licensee agrees that while Adobe may store Licensee Content during the Testing Period, Adobe has no obligation to store such Licensee Content, except to the extent necessary for Adobe to perform the applicable Prerelease Software program for the Hosted Service. In addition, Adobe has no responsibility or liability for the deletion or accuracy of the Licensee Content, including the failure to store, transmit, or receive transmission of the Licensee Content (whether or not processed by the Hosted Service), or the security, privacy, storage, or transmission of other communications originating with or involving use of the Hosted Service. Adobe retains the right to create reasonable limits on the storage of the Licensee Content, including limits on file size, storage space, processing capacity, and similar limitations described in the web pages accompanying the Hosted Service and as otherwise determined by Adobe in its sole discretion.

# 6. Investigation.

- 6.1 **Monitoring Hosted Services and Licensee Content.** Adobe, in its sole discretion, may (but has no obligation to) monitor or review the Hosted Services and Licensee Content at any time. Without limiting the foregoing, Adobe shall have the right, in its sole discretion, to remove any of the Licensee Content if it violates the terms of this Agreement, any law, or is otherwise objectionable.
- 6.2 Monitoring User Activity. Although Adobe does not generally monitor user activity occurring in connection with the Hosted Services, if Adobe becomes aware of any possible violations by Licensee of any provision of this Agreement, Adobe reserves the right to investigate such violations, and Adobe may, at its sole discretion, terminate immediately Licensee's license to access and use the Hosted Services, or change, alter or remove the Licensee Content, in whole or in part, without prior notice to Licensee. If, as a result of such investigation, Adobe believes that criminal activity has occurred, Adobe reserves the right to refer the matter to, and to cooperate with, any and all applicable law enforcement authorities. Adobe is entitled, except to the extent prohibited by applicable law, to disclose any information, including Licensee Content, in Adobe's possession in connection with Licensee's use of the Hosted Services to (i) comply with applicable law, legal process or governmental request, (ii) enforce the terms of this Agreement, (iii) respond to any claims that Licensee's Content violates the rights of third parties, (iv) respond to Licensee's requests for customer services, or (v) protect the rights, property or personal safety of Adobe, its users or the public, and law enforcement or other government officials, as Adobe in its sole discretion believes to be necessary or appropriate.

#### 7. Confidential Information.

- 7.1 **Non-Disclosure.** Each party agrees to hold the Confidential Information in strict confidence and not disclose it to any other party; provided, however, the receiving party may disclose Confidential Information to its employees (a) with a need to know such Confidential Information and (b) that have each signed a written agreement with the receiving party containing confidentiality obligations consistent with those set forth in this Agreement. Receiving party will treat Confidential Information with the same degree of care as it accords to its own confidential information, but in no event with less than reasonable care. Licensee will have no obligation to protect the confidentiality of the Prerelease Software in its final form upon commercial release.
- 7.2 **Serial Numbers, Login Identifiers, and Passwords.** Serial numbers, login identifiers and passwords issued to Licensee (or its employees) are intended for use by the designated individual and shall not be shared with other individuals even if employed by Licensee.
- 7.3 Access to Bug Databases. Licensee's access to Adobe's bug database is intended for use by the Licensee solely to provide feedback to Adobe and Licensee shall not allow access by anyone other than Licensee. Licensee acknowledges that all information contained in Adobe's bug database is Confidential and that any resolution of reported bugs by Licensee will be at Adobe's sole discretion. Licensee also agrees that Licensee will not post any third party confidential information to the bug database.

## 8. No Warranty.

Licensee is aware that the Prerelease Software is a prerelease version and may be prone to bugs and/or stability issues. Adobe provides the Prerelease Software to Licensee "AS IS," and Adobe disclaims any warranty or liability obligations to Licensee of any kind. ADOBE MAKES NO EXPRESS, IMPLIED, OR STATUTORY WARRANTY OF ANY KIND WITH RESPECT TO THE PRERELEASE SOFTWARE INCLUDING, BUT NOT LIMITED TO, ANY WARRANTY WITH REGARD TO PERFORMANCE, MERCHANTABILITY, SATISFACTORY QUALITY, SECURITY OR PRIVACY OF INFORMATION TRANSMITTED TO AND FROM THE HOSTED SERVICE, AVAILABILITY OF THE HOSTED SERVICE, NONINFRINGEMENT OR FITNESS FOR ANY PARTICULAR PURPOSE. IN NO EVENT WILL ADOBE BE LIABLE TO LICENSEE OR ANY OTHER PARTY FOR ANY DAMAGES, INCLUDING ANY LOST PROFITS, LOST SAVINGS OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES EVEN IF ADOBE OR ANY COMPANY REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. LICENSEE BEARS THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE PRERELEASE SOFTWARE. The foregoing exclusions and limitations shall apply to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

# 9. Return of Prerelease Software.

Adobe shall retain all right, title and interest in all Prerelease Software and any associated documents and Confidential Information. Licensee shall return the Prerelease Software to Adobe promptly at Adobe's request, together with any copies thereof. Licensee agrees to destroy all versions of such Prerelease Software and Confidential Information no later than thirty (30) days after Adobe's first commercial shipment of the commercially released version, or at Adobe's written request. Adobe will destroy all Licensee Content at the end of the Prerelease Software program.

# 10. Export Restrictions.

Licensee acknowledges that the Prerelease Software licensed hereunder is subject to the export control laws and regulations of the U.S.A. and other countries. Licensee agrees that it will not export or re-export the Prerelease Software, any part thereof, or any process or service that is the direct product of the Prerelease Software to any country, person or entity subject to U.S. export restrictions.

# 11. Term and Termination.

This Agreement shall commence upon the Effective Date and continue unless terminated as set forth in this section. Each party may terminate this Agreement without cause upon fifteen (15) days prior written notice to the other party. Finally, Adobe may terminate this Agreement immediately upon written notice if Licensee fails to comply with any term of this Agreement. Subject to the provision of section 9, Licensee agrees to destroy all Prerelease Software and Confidential Information immediately upon termination of this Agreement for any reason. Sections 1, 2, 3.4, 3.5, 3.9, 3.10, 4, 7, 9, 11, 12 and 13 survive any termination or expiration of this Agreement.

### 12. Notice.

Any notice given under this Agreement must be in writing by email to the following addresses (or addresses notified in

writing by either party): to Adobe: ContractNotifications@adobe.com; and to Licensee: at Licensee's email address included in the signature block of this Agreement.

### 13. General.

- 13.1 **Governing Law and Venue.** This Agreement will be governed by and construed in accordance with the laws of the United States of America and the State of California, without giving effect to its conflicts or choice of law provisions if Licensee resides in North America (inclusive of United States, Canada, Mexico, United States territories and possessions, and United States military bases wherever located). The parties agree that the United Nations Convention on Contracts for the International Sale of Goods is specifically excluded from application to this Agreement. Where Licensee resides in North America, each party hereby irrevocably consents to the exclusive jurisdiction and venue of the state and federal courts located in Santa Clara County, California for the purpose of any legal action, suit or proceeding brought by either of them in connection with this Agreement. Where License resides outside of North America, the laws of Ireland shall apply.
- 13.2 Assignment; Modification; Entire Agreement. Licensee agrees that the Prerelease Software will not be rented, leased, sold, sublicensed, assigned or otherwise transferred. Licensee will not assign or transfer any rights or obligations under this Agreement without the prior written consent of Adobe and any such attempted assignment or transfer will be null and void. This Agreement may only be modified by a writing signed by both parties. This Agreement (along with accompanying Addenda and Exhibits) is the entire agreement between Adobe and Licensee concerning the Prerelease Software and related Confidential Information (unless a separate non-disclosure agreement governs disclosure of such Confidential Information). This Agreement supersedes, and its terms govern, all prior proposals, agreements, or other communications between the parties, oral or written, regarding such subject matter.
- 13.3 **Notice to Government End Users.** The Prerelease Software and documentation provided hereunder are "Commercial Items," as that term is defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation," as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 or 48 C.F.R. §\$227.7202-1 through 227.7202-4, as applicable, the Commercial Computer Software and Commercial Computer Software Documentation are being licensed to U.S. Government end users (a) only as Commercial Items and (b) with only those rights as are granted to all other end users pursuant to the terms and conditions herein. Unpublished rights reserved under the copyright laws of the United States. Adobe Inc., 345 Park Avenue, San Jose, CA 95110-2704, USA.
- 13.4 Licensee Obligations. If Licensee is entering into this Agreement on behalf of an organization, entity, or institution, Licensee represents he or she is authorized to (a) accept the Agreement on its behalf; and (b) agree that such organization, entity, or institution is liable for its employees' performance under and adherence to the terms of this Agreement.
- 13.5 Injunctive Relief. Licensee acknowledges and agrees that due to the unique nature of Adobe's Confidential

Information, there will be no adequate remedy at law for any breach of Licensee's obligations. Licensee further acknowledges that any such breach will result in irreparable harm to Adobe and, therefore, that upon any such breach or any threat thereof, Adobe shall be entitled to seek appropriate equitable relief, including but not limited to injunction in addition to whatever remedies Adobe may have at law. Licensee will notify Adobe in writing immediately upon the occurrence of any such unauthorized release or other breach.
